Ethical Use of AI in Your Practice and How it Affects Your Clients (ETHICS)

Chatbots, generative language models, voice recognition/transcription software, and other AI technologies show great promise. These and other new technologies may empower lawyers to provide better client service at a lower cost. But lawyers cannot blindly use these technologies. Lawyer competence requires they understand the technologies they use and that the government uses.

- Competence: skills needed in the application of technology to law practice
- Preserving privilege: key components of user licensing agreements that protect you and your clients when implementing technology
- Confidentiality: meeting your obligation to protect clients' information used with AI tools
- Understanding bias: how AI tools can incorporate bias in their data sets and algorithms and how to advocate for your clients
