Ethical Challenges with Access to Justice (Ethics/Access to Justice)

Nationwide, professional responsibility and conduct rules recognize the special role of lawyers to promote the application of equal justice under law. This responsibility extends to lawyers assisting in making the justice system accessible to all, including repairing deficiencies in the administration of justice, as well as providing adequate legal assistance. Our expert panelists will discuss the ethical challenges faced by immigration practitioners in the context of access to justice, particularly during the first 75 days of a new presidential administration. Topics will include:

- High-pressure situations, including balancing pro bono caseloads, maintaining quality representation, and navigating large-scale immigration enforcement actions
- Language, social, and cultural differences between attorneys and clients
- Updates from nonprofit organizations, including leveraging resources and support for immigration advocacy
- Fostering a deeper understanding of the ethical obligations and practical strategies necessary to provide effective and compassionate legal representation to immigrant communities.

Understanding Matter of Lozada (Ethics)

Attorney malpractice is one of the thornier issues facing immigration lawyers, particularly because of the case of Matter of Lozada, 19 I&N Dec. 637 (BIA 1988). Lozada — as a practical matter- has required immigration attorneys to file bar complaints against prior counsel if they are seeking to have a case re-opened due to ineffective assistance or malpractice of prior counsel. The Trump administration went a step further by enshrining this procedure in regulations which were withdrawn by the Biden administration on December 19, 2024. The aim of this panel is to consider:

- What the BIA was seeking to do in Lozada, whether subsequent application of the case actually accomplished the BIA's objectives;
- Whether there is a better or different way to still reach the BIA's objectives that does not require filing a bar complaint;
- What keeps potential changes from being implemented, and;
- What are the implications of change or a decision to keep the standard?

Artificial Intelligence, Ethics, and Immigration Law (Ethics, Technology)

In today's legal landscape, artificial intelligence (AI) is increasingly being harnessed as a tool to streamline law firm operations and enhance efficiency, but its integration into the practice of law poses many ethical considerations. Topics will include:

- A brief introduction to AI and an overview of how AI tools are currently being used by immigration lawyers.
- Al's interaction with the standards for competent representation, including balancing the duty to stay abreast of technological advancements with being aware of their limitations.
- The necessity of safeguarding confidential and sensitive information when using AI, the risks inherent in these tools, such as data breaches and unauthorized disclosure, and best practices for minimizing risk and ensuring data protection.
- Accountability and supervision issues posed by using AI tools, with a particular focus on navigating incorrect or nonexistent information produced by AI, known as "hallucinations."
- The impact that AI tools may have on traditional legal billing models, including enhanced efficiency and the need to account for work completed partially or fully by AI.
- Technology's intersection with the rise of alternative legal service providers, which can address access to justice issues and provide innovative solutions, but also raise ethical concerns, such as the unauthorized practice of law.
